## **ANTI BRIBERY**

Acal BFi is committed to applying the highest standard of integrity, honesty and fairness in its business activities all over the world. We take a zero-tolerance approach towards bribery and corruption in all its forms by, or of, its employees or any persons or companies acting for it on its behalf. The Directors and senior management are committed to implementing and enforcing effective procedures to prevent, monitor and eliminate bribery and corruption.

## **GDPR (GENERAL DATA PROTECTION REGULATION)**

Acal BFi takes its statutory obligations very seriously and as such we have a dedicated team working hard internally and externally to understand the impact of GDPR requirements across the business.

We are in the process of a detailed analysis across the organisation and are progressing key priority areas to implement, upgrade and review.

**Policy Statement** - Acal BFi is committed to acting with integrity, honesty and in an ethical manner in its business activities globally. We conduct all business activities to the highest standard of business practice and in compliance with the rules and regulations applicable to our industry.

**About this policy** - There is increased evidence that the number of counterfeit electronic components in the market is rising. Counterfeit electronic components are defined as being those that are misrepresented in their origins or quality. Although we are not aware of any specific manufacturers producing counterfeit parts and selling them on, Acal BFi is aware of the potential for this situation and the dangers of counterfeit products appearing in the supply chain.

The purpose of this policy is to define actions to be taken by Acal BFi for the avoidance of counterfeit material in the business supply chain.

**Who does this policy apply to** - This policy applies to all persons working for Acal BFi Holdings Limited, Acal BFi UK Limited, Acal BFi Central Procurement UK Limited, Acal BFi Netherlands BV, Acal BFi Holdings GmbH, Acal BFi Germany GmbH, Acal BFi Italy Srl, Acal BFi France SAS, Acal BFi Belgium NV/SA and Acal BFi Nordic AB (together the Acal BFi Group) or on our behalf in any capacity, including employees at all levels, officers, agency workers, seconded workers, volunteers, interns, agents, contractors, external consultants, business partners and casual workers (together referred to as staff).

This policy does not form part of any contract of employment or other contract to provide services, and we may amend it at any time.

**Responsibility for this policy** - The board of directors (the Board) has overall responsibility for the effective operation of this policy, and for reviewing the effectiveness of actions taken in response to concerns raised under this policy.

The Company Secretary has day-to-day operational responsibility for this policy and you should refer any questions about this policy to them in the first instance. This policy is reviewed at least annually by the Company Secretary and the Board.

Staff are invited to comment on this policy and suggest ways in which it might be improved. Comments, suggestions and queries should be addressed to the Company Secretary who will involve the Board where appropriate.

**Counterfeit Prevention** - To minimise the risk of counterfeit products being procured the Acal BFi Group undertakes and encourages the following processes:-

- We only use audited and proven suppliers that we represent for direct purchases of raw materials and components sold by the Acal BFi Group. The procurement of products through this authorised channel provides the Acal BFi Group with assured sources of supply.
- Certificate of Conformance from our suppliers provides traceability back to the point of origin.
- Validation of subcontractor's procurement methodology and sources of supply where procurement is outsourced to another entity as part of our Technology Centre's custom product manufacturing and assembly service.
- Suspect parts awareness training is carried out for all key staff in the supply chain. In the event of discovery of counterfeit materials, those materials will be quarantined, and an investigation will be undertaken to discover their source. Where applicable full details of the infringement will be reported to other potential users, customers and the appropriate government trading standards agency for criminal investigation.

**Training and Communication** - Training on this policy, and on the risk our business faces in its supply chains, forms part of the induction process for all key staff in the supply chain, and regular training will be provided as necessary.

Management at all levels are responsible for ensuring those reporting to them understand and comply with this policy and are given adequate and regular training on it and the impact in supply chains.

Our zero-tolerance approach to counterfeit products in our business and supply chains must be communicated to all suppliers, contractors and business partners at the outset of our business relationship with them and reinforced as appropriate on an ongoing basis.

**Breaches of this policy** - Any employee who breaches this policy will face disciplinary action, which could result in dismissal for misconduct or gross misconduct.

## HANDLING AND STORAGE OF ELECTRONIC COMPONENTS

**Moisture Sensitive Devices** - All devices are handled in accordance with IPC/JEDEC J-STD-033

**Static Sensitive Devices** - There are procedures/infrastructures in place and staff are trained in order to comply with IEC 61340-5 and ANSI/ESD

**Vibration and Shock Sensitive Devices** - Procedures are in place to ensure there is sufficient packing for adequate protection of these devices during normal transit conditions.

## STATEMENT ON RoHS 3 LEGISLATION

The new RoHS Directive 2015/863/EU (RoHS 3) became effective on 31/03/15. RoHS 3 deals with the same hazardous substances and the same maximum concentration limits as the previous Directive. Therefore, all products meeting the substance restrictions of RoHS 1 and 2 remain compliant to the substance restrictions of RoHS 3. The scope of RoHS 3 is expanding to phase in additional phthalates : DEHP, BBP, DBP and DIBP.

As a value added distributor, Acal BFi is committed to complying to all relevant legislation. We are 100% reliant on the manufacturers of the products we sell to provide this information and as such we collect information from our suppliers regarding the status of products supplied to Acal BFi. In some cases we receive a general statement or where a supplier cannot make a statement regarding all of their products we request a certificate of compliance for a specific item.

## CONFLICT MINERAL POLICY

Acal BFi is committed to being socially, economically and environmentally responsible and will not knowingly procure components that contain minerals that are directly or indirectly, financing or benefiting armed groups in the Democratic Republic of Congo (DRC) or adjoining countries or any countries which are defined as conflict-affected or high-risk areas as defined by OECD (Organisation for Economic Cooperation).

We fully comply with EU Directive EU 2017/821 which defines due diligence obligations for Union importers of tin, tantalum, tungsten, and gold originating from conflict-affected and high-risk areas. For our supply chain due diligence we use the CMRT template of RMI (Responsible Minerals Initiative) to investigate and obtain this information from our suppliers.

Under EU Directive 2017/821 Acal BFi is defined as a so called downstream company and as such we have to fully rely on the information received from our suppliers.

Details based on Items or Franchises can be provided upon request.

While the management of Acal is primarily accountable to its investors and shareholders, in managing the business it takes into account all stakeholders in Acal BFi including employees, customers and suppliers, as well as the local communities and environment in which it operates. In a balanced way, without unnecessarily restricting the optimisation of returns, it endeavours to identify and manage any risks to the value of Acal BFi's business from social, environmental and ethical matters, and to take any opportunities presented by a sensible and considerate approach to such matters to enhance shareholder value.

The Board of Acal BFi has adopted policies in relation to corporate social matters, and day-to-day responsibility for implementation of these policies is delegated to the management of Acal BFi's local operating companies. In implementing these policies, the company endeavours to ensure that the cost of managing risks is proportionate to their significance to Acal BFi and its business partners. More specifically, Acal BFi's policies cover the following :-

**General:** Management at all levels in the organisation is committed to taking account of its corporate social responsibility in its actions and endeavours to show due respect for human rights and works to high standards of integrity and ethical propriety. As a multinational organisation, Acal BFi takes account of cultural differences between the various territories in which it operates.

**Employees:** Acal BFi provides equal opportunities to all employees and prospective employees, and does not discriminate on grounds of colour, ethnic origin, gender, age, religion, political or other opinion, disability or sexual orientation.

Clear and fair terms of employment as well as a fair and competitive remuneration policy are put in place. Employees are encouraged to develop their knowledge and skills and to progress their careers to the mutual benefit of themselves and the companies they work for. It is the responsibility of management to ensure that they comply with all local regulations including those relating to the employment of underage staff. Local business units are responsible for developing and implementing effective arrangements for employee communication.

A great deal of importance is attached to the provision of clean, healthy and safe working conditions. In addition to compliance with all local regulations, Acal BFi promotes working practices which protect the health and safety of its employees and other persons who come on to its premises. The company endeavours to protect employees from and does not tolerate any sexual, physical or mental harassment. Health and safety matters are kept under regular review by local management and by the Acal BFi Group management. The Group operates a 'whistle-blowing' policy whereby employees may report in confidence any suspected wrongdoing.

**Business Relationships:** All Acal BFi company members seek to be honest, fair and competitive in their relationships with all customers and suppliers. Every attempt is made to ensure that products and services are provided to the agreed standards and all reasonable steps are taken to ensure the safety and quality of the goods and services provided. Payment is made to suppliers in accordance with the agreed terms, the relevant goods or services having been satisfactorily delivered. It is Acal BFi's policy that no one in the Group should offer or accept any bribes or other corrupt payments, engage in any anti-competitive practices or knowingly be involved in any fraud or money laundering. So far as it is able to and taking into account local cultural and regulatory differences, Acal BFi encourages organisations and people with whom it does business to abide by principles of good practice in relation to their corporate social responsibility.

**Community and Environment:** Each Acal BFi company aims to be sensitive to the local community's cultural, social and economic needs, and seeks to ensure that its activities do not harm the communities as places to work and live in. The company seeks to ensure that its operations do not have a negative impact on the environment. Apart from compliance with all local environmental regulations, Group companies endeavour to promote the effective management of natural resources and encourage energy efficient as well as waste minimisation and recycling where economically viable means of doing so are available. Although the vast majority of products Acal BFi deals with are non-hazardous, where such products are involved it minimises the environmental risks by use of appropriate labelling and technical information in conjunction with proper training and procedures for the handling, storage and disposal of such products. The Group is cognisant of the Restriction of the Use of Hazardous Substances in Electrical and Electronic Equipment Regulations 2004 and the Waste Electrical and Electronic Equipment Regulations, and has implemented procedures to achieve compliance with them.

**Group Structure** – Acal BFi Holdings Limited (ABHL) is the parent company of a group of businesses that operate in the electronics and photonic products industry. Its registered office is in Wokingham, UK. The group includes the following businesses: Acal BFi Holdings Limited, Acal BFi UK Limited, Acal BFi Central Procurement UK Limited, Acal BFi Netherlands BV, Acal BFi Holdings GmbH, Acal BFi Germany GmbH, Acal BFi Italy Srl, Acal BFi France SAS, Acal BFi Belgium NV/SA and Acal BFi Nordic AB (together the Acal BFi Group). The Group has over 360 employees (based in the UK and Europe).

It continues to be priority of the Acal BFi Group to ensure that we trade ethically, source responsibly and work to prevent modern slavery and human trafficking throughout our business and supply chain. We are committed to improving our practices to combat slavery and human trafficking in our business operations and supply chains. We do not tolerate modern slavery or human trafficking in any part of our business, and we expect the same high standards from our third party suppliers and contractors.

**About Acal BFi** – The Acal BFi Group provides electronic and photonic products and customised solutions for technically demanding applications in industrial, renewable, communications, medical and aerospace markets. The business works with third party manufacturers and suppliers and has operating facilities in the following jurisdictions: Belgium, Finland, France, Germany, Italy, The Netherlands, Norway, Spain, Sweden and UK. It also has central operational facilities in Germany and the UK, the primary UK central entity being Acal BFi Central Procurement UK Ltd. In the last year, we have developed further, and refined, our risk management and environmental, social and governance (“ESG”) programmes. We will continue to develop and refine these over the coming years to deliver on our commitment by implementing the steps described below.

**Supply Chains** – The Group’s supply chains are diverse, both geographically (Europe, North America and Asia), and in the nature of the suppliers we work with (size and products supplied). Typically, the Acal BFi Group has long and established working relationships with our suppliers, from whom we source electronic and photonic products.

We continue to work on the identification of any potential modern slavery risks in our supply chains and how we might improve our policies and support direct industry action to cause remediation if ever needed. We welcome customer or other stakeholder dialogue toward ensuring the high standards to which we strive.

We are aware that some of the geographical areas in which the company operates present higher modern slavery risks than others. We seek to mitigate this risk by carrying out due diligence as well as putting in place appropriate procedures and processes.

We are committed to ensuring that there is transparency in our own business and to addressing modern slavery issues should they ever arise. We expect the same high standards in our supply chains.

The Acal BFi Group promotes ESG policies and procedures which take into account the interests of the Group’s employees, the need to foster responsible business relationships with suppliers, customers and others, the impact of operations on workers, the community and the environment, and the maintenance of high standards of business conduct. These ESG policies are part of the Acal BFi Group framework for ensuring that our businesses operate transparently and with integrity and enable mitigation of risk, including potential modern slavery risks.

Our policies and procedures include the following: anti-bribery and corruption programme; business ethics; whistleblowing; health and safety.

**Risk Assessment Processes** – We have a zero tolerance to slavery and human trafficking. To ensure all those in our supply chain and contractors comply with our values we have a risk management and due diligence process in place to support the identification, assessment and management of risks associated with both existing and new suppliers.

The Acal BFi Group maintains a risk register, which includes an evaluation of the risks associated with supply chains and labour practices, such as modern slavery risks. As with all policies and procedures, due diligence processes on existing and new suppliers are regularly reviewed to ensure they remain appropriate and fit-for-purpose.

**Training** – To ensure a high level of understanding of the risks of modern slavery and human trafficking in our supply chains and our business, we expect our employees to fully observe the Acal BFi Group policies and procedures, including those on: modern slavery, anti-bribery and corruption; whistleblowing; health and safety and business ethics.

**Our Effectiveness in Eliminating Modern Slavery** – We will continue to review our internal processes to ensure that all operations are free from modern slavery, so far as possible, and that we have robust systems in place to identify and manage such issues within our supply chains and businesses.

This statement has been published in accordance with section 54 (1) of the UK Modern Slavery Act 2015 and constitutes the Acal BFi Group’s slavery and human trafficking statement for the financial year ended 31 March 2022. It was approved by the board on 21<sup>st</sup> July 2022.

- There is a trained First Aid team and an accident book, located on IRIS.

### **Fire Precautions and Instructions**

- Fire Marshals and identified staff are trained in the use of basic fire fighting equipment. Which is maintained and inspected regularly.
- Fire Risk assessments are carried out periodically.
- Full instructions on fire safety procedures, alarm testing and evacuation processes are located in the health & safety section of the Company Handbook.

### **Electrical Equipment – Portable Appliance Testing (P.A.T.)**

- All mains powered electrical equipment is tested (P.A.T.) by an approved subcontractor to a schedule with records.

### **Electrical Supplies to Premises**

- A Premises Electrical Fixed Wiring Certificate is maintained and electrical work is only carried out by NIC EIC Approved Electrical Contractors.

### **Manual Handling Risk Assessments**

- Manual Handling Risk Assessments and general Risk Assessments are performed periodically and records maintained.
- Appropriate staff are trained in Manual Handling techniques.

### **Display Screen and Workstation Assessments**

- All staff are assessed against a Display Screen and Workstation Questionnaire.

## Office Safety

- Office Safety assessments form part of the annual Risk Assessment programme.

## Housekeeping

- The premises are cleaned daily by a sub-contracted organisation who take full responsibility for all COSHH requirements appropriate to their cleaning materials.

## Soldering Stations

- Procedures exist for the control and maintenance of soldering stations.

### General Office Waste (Domestic)

- Removed from the premises daily by the cleaning contractors and collected by local authorities for disposal under the current domestic waste disposal licensing.
